# 1. OVERVIEW

On Thursday, October 27, 2022, the Link21 Program hosted the third of four virtual Office Hours designed to provide the public an opportunity to engage with the program team. Office Hours were held from 4:30 to 5:30 pm via Zoom with closed captioning and simultaneous Spanish and Cantonese interpretation. A dial-in option was also available for those without internet access. One participant logged in via Zoom, while none used the dial-in option.

A recording of the October 27, 2022, session is posted on the Link21 website.

# **1.1. Meeting Summary**

The Office Hour was facilitated by Link21's Engagement and Outreach Manager, Kimberly Sims from HNTB. Ms. Sims began the meeting with general housekeeping items (e.g., notifying participants the meeting was being recorded and that interpretation and closed captioning were available), and proceeded to introduce the speaker panel:
